AGRICULTURE

WATER

1) The Nebraska State Grange urges all farm operators to have certified water and soil analysis for the application of the correct amounts to be applied, thus preventing excess nitrates from polluting the water supply.

2) The Nebraska State Grange urges that the Water Pollution Control Act to be revised so that the Army Corps of Engineers has authority over only the “navigable waters” and not the “waters of the United States”.

3) The ACP cost-share payment for conservation and livestock pollution abatement facilities shall be continued; and payments be increased to meet the higher costs due to inflation.

4) The Grange encourages small dam structures and good soil conservation practices of percolating water into subsoil, recycling for evaporation and humidity, flood prevention and for irrigation.

5) The State Grange opposes any state control limiting well drilling for livestock or domestic purposes.

6) Where underground water is in short supply, the Grange supports the concept that irrigators ration water equally. Priorities for the use of underground and surface waters should be established in this order: 1) domestic 2) livestock 3)irrigation 4)industry 5)recreation or fish or wildlife.

7) The Nebraska State Grange supports the present laws pertaining to pollution of ground water by industry, agriculture, city waste, and should be strictly enforced, and that adequate funding be provided by the Nebraska State Legislature to enforce these laws.

8) The Nebraska State Grange reaffirms its support to the Nebraska State Law giving powers to the NRD’s (Natural Resource Districts) to research and educate, and if need be, regulate the use of chemicals by farmers and town people so as not to contaminate surface and ground water.

2) The Nebraska State Grange recommends absolutely no farm program benefits for any farm entity taking part in such poor soil stewardship practices as the breaking up of Class VI and Class VII land.

NRD (Natural Resource Districts)

1) The Nebraska State Grange opposes the use of Natural Resource District funds where the primary purpose of the project is recreation.

2) The Grange urges the Natural Resource Districts (NRD's) to mail ballots and all project information material to each property owner within an NRD project area which is to be financed by a special assessment on such real property. All affected property owners in a special project shall have an equal vote and that the election shall be conducted in a traditional method, whereby, a majority of votes cast makes the decision.

AGRICULTURAL MARKETING

1) Grange urges that American farmers have access to a free and unrestricted world market; and that the Grange go on record to support giving the farmer the right to sell and deliver grain and other commodities direct to foreign nations without interference from organized labor unions or the government, including the amount of grain required to be shipped in American ships, with the grain being exempt from cargo preference regulations.

2) The Grange should work vigorously and solicit the help of other farm organizations to form commodity marketing cooperatives that may draw up their contracts and bargain with processors or retail outlets for pricing of their product.

3) The Grange supports regulations that require any imported meats and produce to meet all or exceed U.S. Health quality and residue standards. The Grange supports requirements that all food for human consumption be permanently identified as to country of origin (COOL). The Grange supports uniform inspection standards for fish, poultry, or red meat, foreign or domestic.

4) If an embargo becomes necessary, the Grange would support only a complete embargo on all products.

5) Grange supports the principle of marketing orders as an equitable way for farmers to market their product and should be preserved.

CONSERVATION

1) The Nebraska State Grange supports the concept of conservation tillage practices employed in the production of crops on erodible land.

2) The Nebraska State Grange recommends absolutely no farm program benefits for any farm entity taking part in such poor soil stewardship practices as the breaking up of Class VI and Class VII land.

18) The Nebraska State Grange supports efforts to demand that in all reports of red meat and/or animal production in the United States, a clear delineation be made between those animals and/or pounds of meat from animals born and raised in the United States, as separate from those animals and/or pounds of meat that have been imported from countries outside the United States.

19) The Nebraska State Grange supports the position that any industrial concentration of livestock feeding in Nebraska be by a sole proprietor, general partnership, or family corporation.

20) The Nebraska State Grange supports the use and promotion of soybean fuels and soybean food products.

21) The Nebraska State Grange encourages the development of value added products with the aid of non-farm groups for the benefit of the agricultural community.

22) The Nebraska State Grange supports mandated limitation of packer controlled cattle to allow supply and demand to set prices.

23) The Nebraska State Grange recommends that a border duty equal to the economic advantage of raw or processed products be imposed on products entering the United States for consumption.

24) The Grange supports the restoration of normal trade relations with Cuba.

25) The Nebraska State Grange supports the development of a uniform program of identification of meat animals by the United States Department of Agriculture.

26) The Nebraska State Grange endorses Teff research between Nebraska/Kansas and Ethiopia pursuing farming and marketing practices that will raise income and pricing control of internationally cooperating smallholder farmers.

27) The Grange supports strict enforcement of the Packers and Stockyards Act of 1921 and supports legislation and rulings that will strengthen the Packers and Stockyard Act to ensure producers have available adequate price discovery, price transparency and fairness in the marketing of U.S. livestock.

28) The Nebraska State Grange vigorously opposes any effort that would abolish the current practice of carcass quality pricing of beef and swine in favor of one value fits all price concept.

16) The Nebraska State Grange supports the USMCA (United States, Mexico and Canada..

17) The Nebraska State Grange supports work to assure that livestock prices are equalized in the open market for all livestock of equal quality.

18) The Nebraska State Grange supports efforts to demand that in all reports of red meat and/or animal production in the United States, a clear delineation be made between those animals and/or pounds of meat from animals born and raised in the United States, as separate from those animals and/or pounds of meat that have been imported from countries outside the United States.

19) The Nebraska State Grange supports the position that any industrial concentration of livestock feeding in Nebraska be by a sole proprietor, general partnership, or family corporation.

2) The Nebraska State Grange strongly recommends that the existing pattern of separate, independent boards of producers responsible for each respective commodity be retained.

3) The Nebraska State Grange supports the application of check off fees to all beef, swine, and other agricultural commodities sales including commodity options.

4) The Grange opposes any effort to exempt commodity checkoff funds from being subject to the Freedom of Information Act (FOIA).

2) Total payments from all government farm programs to each person should be limited to \$80,000 per year per person.

3) Import and export policies be adopted and administered to ensure a level playing field for all producers (i.e. export enhancement program).

4) That the term of CCC (Commodity Credit Corporation) commodity loans be 12 months.

5) Price support payments must be paid out on a counter cyclical basis that will increase the per unit payment to the producers suffering the largest loss below the normal yield, and reduce the per unit payment for producers whose production is over a normal yield.

7) Continuation and expansion of the CSP (Conservation Security Program) on a national basis.

8) The Nebraska State Grange recommends that farm disaster payments be available only if federal crop revenue coverage insurance is not available.

LESTER LARSEN ANTIQUE TRACTOR MUSEUM

1) The Nebraska State Grange supports maintaining the Lester Larsen Tractor Museum.

DOMESTIC WASTE AND CHEMICALS

1) The Grange supports efforts, installations, and safe ways to dispose of chemical containers, other hazardous wastes, and any water contaminants.

2) The Grange supports allowable limits (of observed and/or established) as to the amount of nutrients (organic or inorganic) which can be applied to the land to avoid over saturation of those nutrients of the land.

LIVESTOCK PRODUCTION

1) The Grange supports long-standing regulations and laws and future legislation that protects the rights of established livestock farms and feeding operations.

2) The Nebraska State Grange supports maintaining the Lester Larsen Tractor Museum.

DOMESTIC WASTE AND CHEMICALS

1) The Grange supports efforts, installations, and safe ways to dispose of chemical containers, other hazardous wastes, and any water contaminants.

2) The Grange supports allowable limits (of observed and/or established) as to the amount of nutrients (organic or inorganic) which can be applied to the land to avoid over saturation of those nutrients of the land.

LIVESTOCK PRODUCTION

RISK MANAGEMENT

1) The Nebraska State Grange supports risk management education in agricultural production and marketing at secondary and post secondary levels, formally and informally, for better understanding and use for greater profits to farmers.

FOOD SAFETY

- 1) The Grange supports and encourages the use of irradiation as a tool in making our food supply even safer.
- 2) The Nebraska State Grange supports efforts to educate all stakeholders involved in the production of food and fiber in the prevention of bio-terrorism.
- 3) The Nebraska State Grange supports state and national regulatory efforts to closely monitor and test animals on game farms in order to prevent the spread of potentially devastating communicable diseases to surrounding domestic and wild animals. The Grange also recommends that the federal government monitor as closely as possible the health status of animals growing in the wild.
